COVID-19 COMMUNITY CURFEW/SHELTER IN PLACE ORDER 2020

1. INFORMATION

- 1.1 This Coronavirus (COVID-19) curfew Policing Plan has been developed to support the Bermuda Police Service (BPS) *and the Bermuda Community* in dealing with the threats posed by COVID-19.
- 1.2 The Commissioner of Police has declared the COVID-19 situation as a Critical Incident as per the Critical Incident Command SSI.
- 1.3 With a view to ensuring public safety, His Excellency the Governor has issued a Proclamation of Emergency under section 14 of the Bermuda Constitution Order and has exercised his powers under section 3 of the Emergency Powers Act 1963 by declaring a State of Emergency, that allow for the enforcement of EMERGENCY POWERS (COVID-19 SHELTER IN PLACE) REGULATIONS 2020 to be enforced. As a result, EMERGENCY POWERS (COVID-19 SHELTER IN PLACE) REGULATIONS 2020 will come in to effect at 0600hrs on April 4th 2020 for a period of two weeks.
- 1.4 This Order will be in place for all Bermuda residents commencing at 0600hrs on Saturday 4th April 2020 and concluding at 0800hrs Saturday April 18th 2020. During this period no persons are permitted on any public highway unless exempted or under the authority of a Chief Inspector Curfew (Mr. R. Cardwell).
- 1.5 The Shelter In Place order is to be strictly enforced.
- 1.6 Key message is that the intent is to mitigate the risk of COVID-19 transfer within communities.

2. GOLD STRATEGY

The following Strategy has been set by the Gold Commander

Strategic Aim

To preserve life and protect the public by working in partnership with Bermuda Government Department of Health and other agencies to provide a coordinated response to **contain** cases of infection; **delay** the onset of cases in Bermuda **mitigate** the impact of cases on the communities; and plan for **recovery**. In order to do this, we will deliver on the following objectives

Objectives

1. Preserve life, protect the public by assisting Dept. of Health to contain, delay, and mitigate the spread of the virus.
2. Protect the health and safety of Police Officers and Police Staff, including the provision of and guidance on using personal protective equipment.
3. Take steps to delay the onset of infection within the organisation.
4. Ensure Business Continuity plans prioritise the functions of the Service to ensure that critical services continue during times of significant staff absences.
5. Reassure and inform the public by supporting Public Health guidance and Public Health messages through joint communications.
6. Ensure that community tension and intelligence/information are managed through application of the national intelligence model.
7. Support Local partner agencies and local communities to mitigate the impacts of the virus.
8. To maintain the rule of law and preserve order in Bermuda and to support National Security operations where required.
9. To minimise disruption to normal life as far as practicable.
10. Plan for recovery from the outbreak and return the Service and communities to a new normality as soon as practicable
11. To maintain public trust and confidence in the Bermuda Police Service.

3. CRITICAL SERVICES/FUNCTIONS

In conjunction with the Gold and Silver plans this plan is designed with a view to:

- 3.1. Maintenance of law and order, including the provision of high visibility police patrols to reduce the occurrence of theft, burglaries and anti-social behaviors which can occur when properties are vulnerable.
- 3.2. Maximizing the safety of Police Officers
- 3.3. Minimizing the risk to members of the public.
- 3.4. Assisting in the recovery process and return to normal policing activities.
- 3.5. Maintain the confidence of the community.

4. INTENTS

- 4.1. **The intent being to suppress the transfer of the COVID-19 virus through the control of unnecessary social movement and influencing of social distancing.**
- 4.2. His Excellency the Governor has declared a State of Emergency requiring all residents to remain at home at all times except for essential travel.
- 4.3. This Order give powers to put in place Curfew restrictions on all persons travelling on the highways of Bermuda between the hours of darkness.
- 4.4. To that end this plan has been developed to direct Police Officers, supported by their colleagues in the Royal Bermuda Regiment on methods to enforce these regulations.
- 4.5. Public Advisories will be sent out by Dept of Communications as follows:
 - 4.5.1. Public advised to only use grocery store closest to home (see Appendix B)
 - 4.5.2. Only one family member to go grocery shopping
 - 4.5.3. Groceries to be purchased for one week supplies only.
 - 4.5.4. Bulk buying will be challenged by Security in first instance and RBR/BPS in second.
 - 4.5.5. All beaches and recreational spaces to be closed
 - 4.5.6. No public exercising (running cycling or walking) to be permitted.

Operational Outcomes

Preferred Outcomes:

- The situation passes off safely with no serious crime, serious injury to any person or serious or widespread damage to property taking place.
- We have identified risks and threats in a timely manner and, working with partner agencies where appropriate, we have reduced or eliminated them wherever possible, through proportionate measures.
- We successfully reduce and prevent crime
- Engagement with partners and the public is effective and positive and that trust and confidence in the operation and in policing is enhanced.
- Those affected by the situation feel reassured and confident regarding their safety.

SENSITIVE

- We maintain the trust and confidence of the local and wider community affected by the situation.
- Plans are tested and the multi-agency response is agreed and understood by all.

Acceptable Outcomes

- The situation remains safe for all residents and those affected by the virus, including our staff.
- Crime, minor injury or limited disorder or anti-social behaviour does occur, where it could not have been foreseen and prevented and our response is effective and reassuring.
- We have identified risks and threats in a timely manner and, working with partner agencies where appropriate, we have prevented them increasing by influencing those under the Quarantine Order to take heed of the Order.
- Where misunderstandings do occur, communication has been inadequate, or trust and confidence has the potential to be undermined, this is limited and we act quickly to address any shortcomings, correct any errors and maintain trust and confidence.
- Where a Multi-Agency response or contingency is required to be enacted, these are co-ordinated effectively across agencies and includes effective coordination of communication messages, keeping the public informed and supporting the return to 'normality' as quickly as possible.

Unacceptable Outcomes

- That officers or staff behave in an unprofessional or discriminatory manner or there is a perception that they have done so and trust and confidence in policing is damaged.
- Communication is poor with partners or the public leading to misunderstandings or having the effect of undermining trust and confidence in us or partner agencies as a result.
- That the actions of any officer is unprofessional or disproportionate with regards to their intervention or use of force.

5. METHOD

- 5.1 The operation will be under the remit of the Bronze commander.
- 5.2 Officers from Departments across the Service will be deployed in conjunction with RBR personnel.
- 5.3 There will be a combination of static and roving Roadside Community Advisory Points at key junctions across the island during the day shift and roving Roadside Community Advisory Points and Reassurance patrols during the night shift.
- 5.4 The Bronze Commander will carry out a morning briefing with BPS and RBR personnel at 0900hrs and 1400hrs each day at the PRC hall prior to staff being deployed to various Roadside Community Advisory Points across the island. Additionally, they will be reminded of the set Policing Style and the five step appeal model. See section 11 of this plan.
- 5.5 Drivers and persons using the highways will be stopped and advised to return immediately to their homes.
- 5.6 Persons who have written permission of the Minister of National Security will be allowed to proceed. Persons who fall into the professional categories listed in the Order will also be allowed to proceed.
- 5.7 Any persons who are found on the highways without permission (or not falling into the listed categories) and have no valid reason for being on the road will be instructed to return to their residence
- 5.8 Grocery Stores, will be monitored by Police and RBR soldiers to ensure public order is kept and social distancing is observed as appropriate.
- 5.9 As per the Government Instructions, Security at the Supermarkets will only be letting in persons whose last names start with letters A-K on Monday, Wednesday and Fridays and L-Z on Tuesdays Thursday and Saturdays, with Sundays reserved for Seniors. Patrols, inclusive of Parishes and PSUE, and the designated Public Reassurance Patrols are to be made available to assist the Security with enforcing this Order.
- 5.10 Parks, beaches, golf courses and other social spaces will be monitored for compliance with restrictions. Parks Dept. will be on standby and remote working should they be required to assist in this endeavor.
- 5.11 Powers of arrest under the Summary Offences Act will be considered during the duration of this order where no other method appropriate on consultation with Silver Commander.
- 5.12 In all other cases, information will be recorded in order to proceed by summons where appropriate.

SENSITIVE

- 5.13 All advisory points will be under the direct supervision of a day shift BRONZE Commander for the operation.
- 5.14 All officers and Regiment personnel will be fully briefed in advance in respect of their roles and responsibilities prior to deployment on advisory points and roving reassurance patrols.
- 5.15 CCTV Coverage:
 - 5.15.1 To be monitored from COMOPS and BAS-SERCO employees
- 5.16 Shifts will be assigned dependent on hours required and authorised by Gold on advice from the EMO. Officers will be assigned from various Departments across the Service at the discretion of the Bronze Commander for the area
- 5.17 The Royal Bermuda Regiment has been embodied from 18th March 2020 and will be deployed in support of BPS officers.
- 5.18 Detainee levels will be regularly reviewed by Silver with a view to reducing the numbers of persons in direct contact with Custody staff in order to prevent transmission of virus. Detainees will only remain in Police Custody if arrested for serious crime or where no other means of disposal exist.
- 5.19 Uniform of the day will be worn. Those officers who do not have uniform will be required to wear their police rain jackets or reflective tabards. RBR Soldiers will wear reflective tabards.
- 5.20 Protective vests, flashlights and all issued officer safety equipment are to be carried by all officers currently trained.

COMPLAINT AND NON-COMPLIANT OFFENDERS

Compliant first time offenders will have their name, DOB and address taken and radioed into ComOps to be logged under one Memex entry CAD # 2020-003254 and the offender will be instructed to return to their home address.

Repeat Offender will have their name, DOB and address taken and radioed into ComOps to be logged under Memex entry CAD # 2020-003254 and will be prosecuted via summons.

Non – compliant offenders and third time offenders will be arrested and placed before the courts.

7. BRIEFINGS

- 7.1 Bronze Commander will hold a daily briefing at 0900hrs at the PRC Hall with RPU and RBR. Bronze Commander will consider daily if there is a need to hold a 1400hrs briefing for a debrief of the morning enforcement activities before commencing the afternoon enforcement activities.
- 7.2 The above briefings will be held by the SOOC on Saturdays and Sundays.
- 7.3 The Public Reassurance Patrols will be briefed by the Incident Commanders at 0800hrs and 1200hrs at ComOps yard.

8. RISK ASSESSMENT & HEALTH AND SAFETY.

- 8.1 The use of PPE shall be considered on a case by case basis
- 8.2 Officers should be encouraged to follow safe social distancing at all times
- 8.3 Waterless hand cleaners and frequent hand washing where possible is encouraged.
- 8.4 When handling drivers licenses and/or other documentation, the use of nitrile gloves is recommended.

9. COMMUNICATIONS

- 9.1 All critical communications to be conducted via police radio rather than cell phone in order to create a corporate record of decisions made.
- 9.2 Channel 3 will be used by all personnel associated with this Order unless otherwise instructed. Or a joint agency channel on the new radio system.
- 9.3 All other units will use their regularly assigned channels
- 9.4 A separate media plan utilising traditional and social media will be deployed to ensure a "No Surprises" approach. All media communications will be in line with directions from Government Dept. of Communications.

10. POLICING STYLE

10.1

- We will have an approachable, engaging and helpful policing style.
- We will ensure a reassuring presence throughout the event which may include the deployment of overt specialist assets.
- We will deal positively with any behaviour that adversely infringes on the rights of others.
- We will seek to ensure there is a balance between effective and proportionate policing, keeping people safe.
- We will also ensure that we support and look out for each other as we go about our designated duties, keeping people safe and keeping each other safe at the same time.
- The BPS will treat people fairly and as individuals, but there must be no assumption that people will be permitted to break the law, including assaults against Police officers and staff, as well as representatives of other agencies working on the operation.
- As always, officers have discretion as to how they deal with people who break the law, particularly for minor offences, but this does not extend to ignoring people who they see breaking the law or ignoring complaints from members of the public about law breaking.
- The presumption will be that any suspect for a criminal offence will be dealt with at the time particularly if it results in injury assault or offences involving harm to another or damage/ loss of property.
- If officers are unsure they are to consult with their first line supervisor for the operation.

10.2 **The 5 Step Appeal model**

The 5 Step Appeal model is used to de-escalate conflict. It is useful when resolving a difficult situation or where a person refuses to comply with a request.

These 5 steps will be used before any use of force is deemed appropriate.

1. Simple Appeal:

To make a reasonable request of somebody.

2. Reasoned Appeal:

SENSITIVE

The reason/understanding as to why you are making the request.

3. Personal Appeal:

Appeal to their better nature, why do you want them to do it?

4. Final appeal:

The last chance to get the person to stop what they are doing.

Offer alternatives/ options/consequences.

"Is there anything I can say or do that will get you to....."

5. Action:

Make sure you do what you said you are going to do, don't make threats!

11. HUMAN RIGHTS

The Silver Commander when briefing officers is to remind that the when carrying out their duties, that they should do so based on the following variables:

- Justified
- Authority
- Proportionate
- Auditable
- Necessary
- Least Intrusive

12. POWERS & POLICY

SUMMARY OFFENCES ACT 1926

Arrest without warrant

24 A police officer may arrest without warrant any person whom he finds committing an offence against this Act, or whom he finds committing an act which he honestly believes on reasonable grounds to constitute an offence against this Act.

Punishment of offenders

25 Where a person commits an offence under this Act: Punishment on summary conviction: imprisonment for 6 months or a fine of \$2,880 or both such imprisonment and fine.

EMERGENCY POWERS (COVID -19) REGULATIONS 2020

Enforcement powers

15 (1) An enforcement officer may stop any person and require the person to answer any questions to enable the enforcement officer to ascertain the person's identity and whether the person is in compliance with these Regulations, and where the person does not satisfy the enforcement officer that the person is exempt or otherwise in compliance with these Regulations, the enforcement officer may—

- (a) direct the person to return immediately to the person's place of residence; or
 - (b) detain and convey the person to the person's place of residence.
- (2) The power in paragraph (1) may be exercised where a person is at any place other than the person's place of residence.
- (3) For the purposes of exercising the power in paragraph (1), an enforcement officer may enter any place other than a residence.
- (4) An enforcement officer may use reasonable force, if necessary, in the exercise of a power under this regulation.

See Interpretation Section:

"Enforcement officer" means—

- (a) a police officer; or
- (b) a member of the Royal Bermuda Regiment.

Offences

16 A person who fails to comply with any of these Regulations commits an offence and may be arrested without warrant, and is liable on summary conviction to a fine of \$10,000 or a term of imprisonment of six months, or both

SUMMARY OFFENCES (CURFEW) ORDER 2020

Whereas the Governor is satisfied that it is in the interests of public safety that the public should be kept off the highways during certain hours of darkness, the Governor, in exercise of the power conferred by section 14(2) of the Summary Offences Act 1926 makes the following Order:

Citation

1 This Order may be cited as the Summary Offences (Curfew) Order 2020.

No person permitted on highways during curfew hours

2 (1) Subject to paragraph 3, no person shall be permitted on any highway during the curfew hours.

(2) In paragraph (1)—

“curfew hours” means [5.30pm to 6am];

“highway” includes every public road, street, lane, alley, wharf or other public place in Bermuda.

Exemptions

3 (1) A person who has the written permission of a police officer of the rank of Chief Inspector or above is exempt from this Order.

[(2) The following persons are also exempt from this Order—

- (a) Government Ministers;
- (b) Judges and magistrates;

SENSITIVE

(c) members of the Royal Bermuda Regiment, the Bermuda Police Service, the Bermuda Fire and Rescue Service and the Department of Corrections, when on duty, or travelling to and from duty;

(d) any registered medical practitioner, registered nurse, ambulance driver or crew, or other health professional whether employed by the Bermuda Hospitals Board or otherwise, when such persons are on duty, travelling to or from duty, or otherwise rendering medical assistance to any person.]

PUBLIC HEALTH (COVID-19) REGULATIONS 2020

PART 4 ENFORCEMENT

Application to Justice of the Peace Where a person has failed to comply with an order by the Health Officer made under these Regulations, to take the necessary precautions to prevent the transmission in Bermuda of COVID-19, the Health Officer may make an application to the Justice of the Peace, as provided under section 83 of the Act, that the person has failed to— comply with the requirements of active monitoring or public health supervision; isolate himself from other persons; submit to an examination by a medical practitioner or Health Officer; place himself under the care and treatment of a medical practitioner; or conduct himself in such a manner as not to expose another person to infection.

Where the Justice of the Peace is satisfied with the application made under paragraph (1), he may, with the consent of the Minister, order that the person who has failed to comply with requirements under paragraph (1)— be taken into custody and be placed in isolation; be taken into custody and be admitted to, detained and treated at the hospital; be examined by a medical practitioner or Health Officer to ascertain whether or not the person is infected with COVID-19; or 17 18 19 (1) (a) (b) (c) (d) (e) (2) (a) (b) (c) 9 PUBLIC HEALTH (COVID-19) REGULATIONS 2020 be treated for COVID-19, where on examination of such person it is found that he is infected with the virus. The admission and treatment of the person at the hospital or place of isolation as ordered under paragraph (2) shall be at the cost of the individual.

Authority to apprehend

An order made under regulation 19 is authority for the Health Officer to direct a police officer to— locate and apprehend the person who is the subject of the order; and deliver the person who is the subject to the order to the place of public health supervision, active monitoring or isolation named in the order, or to a medical practitioner for examination. The police officer shall do all things reasonably able to be done to locate, apprehend and deliver the person to the place of public health supervision, active monitoring or isolation specified in the order.

The police officer who apprehends a person who is the subject of an order pursuant to paragraph (2) shall promptly— inform the person of the reasons for the apprehension and of the person's right to retain and instruct counsel without delay; and tell the person where the person is being taken. An order made under regulation 19(2)(b) is authority to detain the person who is the subject of the order in the place of public health supervision, active monitoring or isolation named in the order and to care for and examine the person and to treat the person for COVID-19 in accordance with generally accepted medical practice for such period as the medical practitioner or Health Officer shall determine.

Subject to regulation 23(2), an order made under regulation 19(2)(c) is authority to detain the person who is the subject of the order in the place of public health supervision, active monitoring or isolation named in the order and to care for and examine the person for a period not exceeding 14 days.

Quarantine Act 2017

Offences and proceedings

Any traveller or conveyance operator who, contrary to this Act, or the regulations or orders made under this Act—

refuses to answer or knowingly gives an untrue answer to any inquiry, or who intentionally withholds any information reasonably required of him by a Health officer or other person acting under such authority, or who knowingly furnishes to any such officer or other person any information which is false;

refuses or wilfully omits to do any act which he is required to do, or who refuses or wilfully omits to carry out any lawful order, instruction or condition made, given or imposed by a Health officer or other person acting under such authority; or

assaults, resists, wilfully obstructs, or intimidates a Health officer or other person acting under such authority, or who otherwise obstructs the

execution of this Act, or regulations or orders made under this Act, commits an offence.

Any traveller or conveyance operator who commits an offence under subsection (1) is liable on summary conviction to a fine not exceeding \$25,000, or to imprisonment for a term not exceeding six months or to both such fine and imprisonment.

Police powers and duties

Where a Health Officer gives an order, instruction or condition to a traveller or conveyance operator in connection with the exercise of his functions under this Act and the traveller or conveyance operator fails or refuses to comply with such order, instruction or condition, the Health Officer may, with the assistance of a police officer, arrest a traveller or conveyance operator and charge with an offence under section 11(1).

A police officer may arrest without warrant any traveller or conveyance operator whom he has reasonable grounds to believe failed to comply with the requirements of this Act or of regulations or orders made under this Act or has committed an offence under this Act.

A traveller or conveyance operator who is arrested under this section may be placed in detention by a Health Officer until such time as a Government Medical Officer acting on the instructions of the Chief Medical Officer has determined that the traveller's state of health is such as not to pose a risk of significant harm to public health. In this section, "Government Medical Officer" has the meaning assigned to the Term in section 2 of the Public Health Act 1949.

Police Act 1974

Section 5 – Powers & Duties of the Service

(a) A member of the Service, unless duly excused or interdicted from duty-

(b) Shall at all times have all the powers and immunities conferred upon Police Officers by any statutory provision; and

(c) Shall at all times be bound to discharge any of the duties

Public Order Act 1963

Conduct conducive to breach of the peace

3 (1) Any person who, in any public place or at any public meeting, uses threatening, abusive, or insulting words, gestures or behaviour with intent to provoke a breach of the peace, or whereby a breach of the peace is likely to be occasioned, or **Pride Day Operational Order 2019 Page 24 of 31**

Power to deal with items obscuring or concealing identity

315G (1) A police officer may in any public place, stop a person and –

(a) require that person to remove any item which the police officer reasonably suspects that person is wearing to obscure or conceal his identity; or

(b) seize any item which that person has and which the police officer reasonably believes that person could wear to obscure or conceal his identity.

(2) A police officer may use reasonable force, if necessary, in the exercise of the powers conferred under subsection (1).

(3) A person who fails to comply with an order from a police officer under subsection (1) or obstructs a police officer in the course of performing his duties under subsection (1), commits an offence and is liable on summary conviction, to a fine not exceeding \$2,500 or to imprisonment for a term not exceeding three months or to both such fine and imprisonment.

Protection of public premises and activities

20 (1) Any person who –

(a) enters any public premises as a trespasser; or

SENSITIVE

(b) not being engaged in the discharge of duties, or the performance of obligations, connected with activities normally carried on in any public premises, wilfully neglects or fails to comply as soon as is practicable with a direction to leave those premises, being a direction given by –

(i) a person authorised in writing by a body or authority owning, or lawfully occupying or using, the premises to give such directions with respect to those premises; or
(ii) a police officer; or

(c) knowingly interferes with the carrying on of any lawful activity in any public premises, commits (without prejudice to any other provision of law) an offence against this Act:

Provided that nothing in paragraph (c) shall operate to prevent –

(i) any lawful picketing carried on outside any public premises; or
(ii) any other lawful act done

By or on behalf of a registered trade union in contemplation or in furtherance of a labour dispute under the Labour Relations Act 1975 [title 18 item 1].

(2) A police officer may remove from any public premises any person who commits an offence under subsection (1) (b) in those premises.

(3) A person authorised to give directions for the purposes of subsection (1) (b) with respect to any public premises shall, if so required by any person to whom a direction is given under that paragraph to leave those premises, produce his authorisation to give such a direction.

(4) References in this section to public premises include references to any building which is owned, occupied or used for any purpose by or on behalf of the Government or a local or public authority or which is occupied or used for parliamentary, judicial or police purposes and includes a school, and any part of any such building the curtilage thereof and the boundary walls thereof and any place or thing which is within the curtilage of any such building.
