1. INTRODUCTION

1.1 SECURITY CLASSIFICATION

This is as opposed to using Incident data, which is the initial request from the public or the direct deployment of police resources to deal with something that may be recorded as an offences.

1.3 EXPLANATION OF GRAPHS

The graphs used in this report include standard deviation, which has been used as a means of objectively measuring how much the crime rate has varied over time and is useful in identifying extreme highs and lows of crime. Standard deviation has been used so that where the crime rate is above the red line (2 standard deviation above the mean average), it is considered exceptionally high. Where the crime rate is below the blue line (2 standard deviation below the mean average), it is considered exceptionally high. Where the crime rate is below the blue line (2 standard deviation below the mean average), it is considered exceptionally low. In both cases it can be referred to as statistically significant (high or low) and is an indication of whether the quarterly statistics are exceptionally high or exceptionally low.

<u>1.4 AIM</u>

The aim of this report is to produce accurate, timely, objective information that:

- Enables informed decisions to be made on the types of crime that threaten the safety of the community.
- Is used to proactively manage risks to the island and ensure effective policing, redeploying and directing resources at a strategic and tactical level, as required.
- Facilitates effective and open communication with our stakeholders, developing the means to inform them of the plans, efforts and progress being made by the BPS.
- Provides meaningful information as one of the means of reassuring communities in Bermuda.

1.5 Executive Summary

In 2015, **4** people were murdered, with **1** person killed by a firearm and an additional **5** people suffered firearm related injuries. In 2014, **4** people were murdered, with **2** people killed by a firearm and an additional **8** people suffered firearm related injuries.

All Crime in 2015 increased by **+10.5%** compared to 2014. Q4 2015 had an increase of **+1.0%** when compared to the previous quarter (Q3 2015) and an increase of **+5.2%** when compared to Q4 2014.

When Q4 2015 is compared to Q3 2015, Crimes Against The Person and Crimes Against the Community **decreased** by **-14** and **-9** offences respectively, while Crimes Against Property **increased** by **+32** offences. A summary of the 3 key crime headings and 20 crime categories for Q4 2015 in comparison to the previous quarter (Q3 2015), the same quarter last year (Q4 2014) and the 5 year trend is shown below in Figure 1:

2. ALL CRIME

2.1 SUMMARY


Figure 3: All Crime (Last 5 Year Comparison 2011 - 2015)

The total for All Crime in Q4 2015 was **943**, an **increase** of **+9** offences or **+1.0%** compared to Q3 2015, as can be seen in Figure 2, below. In comparison to Q4 2014, Q4 2015 has **increased** by **+47** offences or by **+5.2%**. The total for 2015 was **3,750**, a year on year increase of **+356** offences or **+10.5%** as can be seen in Figure 3, below.

Figure 2: All Crime (Last 5 Quarter Comparison Q4 2014 - Q4 2015)

2.2 TRENDS

Q4 2015 shows a slight **increase** in offences when compared to Q3 2015, however with a range of only 10 offences recorded for the last 4 quarters (between 934 and 943), All Crime remains level over the last 3¹/₂ year period. This can be seen in Figure 4, which shows All Crime for the last 20 quarters, with Q4 figures highlighted in boxes:





3. CRIMES AGAINST THE PERSON (CATP)

3.1 SUMMARY


Figure 6: Crimes Against the Person (Last 5 Year Comparison 2011 - 2015)

The total for CATP in Q4 2015 was **167**, a **decrease** of **-14** offences or **-7.7%** compared to Q3 2015, as can be seen in Figure 5, below. In comparison to Q4 2014, Q4 2015 has **increased** by **+11** offences or by **+7.1%**. The total for 2015 was **708**, a year on year increase of **+172** offences or **+32.1%** as can be seen in Figure 6, below.

3.2. TRENDS

Q4 2015 shows a slight **decrease** in offences when compared to Q3 2015. The total for 2015 is higher than 2014 due to the exceptionally low offences in Q1 and Q2 2014. A summary of Crimes Against The Person for the last 20 quarters can be seen in Figure 7, with Q4 figures highlighted in boxes:

4. FIREARM INCIDENTS

Firearm Offences are included within Crimes Against The Community (Section 5); however Firearm Incidents¹ may not necessarily be recorded as offences, as often there is no suspect or even a victim.

4.1 SUMMARY





Figure 8: Firearm Incidents In Bermuda (Q1 2011 - Q4 2015)

In Q4 2015 there were **9** Firearm Incidents of which **4** were Confirmed Firearm Incidents and **5** were Recoveries of Firearms and/or Ammunition. In Q3 2015 there were **12** Firearm Incidents of which **3** were Confirmed Firearm Incidents and **9** were the Recoveries of Firearms and/or Ammunition. In 2015 there were **33** Firearm Incidents of which **12** were Confirmed Firearm Incidents and **21** were Recoveries of Firearms and/or Ammunition. In 2014 there were **25** Firearm Incidents of which **17** were Confirmed Firearm Incidents of Firearms and/or Ammunition. A summary of Firearms Incidents for the last 20 quarters can be seen in Figure 8:

¹ To enable accurate recording, analysis and reporting of firearm incidents, the BPS classifies firearm incidents into 2 categories which are split into **Confirmed** or **Recovery Of A Firearm and Or Ammunition**. A **Confirmed** incident is where a person has been shot (fatally or wounded), a person has been shot at and corroboration is provided by forensic recovery of ballistic material, CCTV footage showing a firearm, reliable witness testimony or a person is charged with a firearms offence connected to the incident, a firearm is used in the commission of a criminal act and corroboration has been obtained, or a report of a firearm discharged and forensic material (bullet casings) have been recovered. A **Recovery Of A Firearm and Or Ammunition** is where a firearm, ammunition or imitation firearm is recovered by police.

4.2 FIREARM TRENDS

In Q4 2015 there were **5** firearms and/or ammunition recovered, **1** fatality, **4** injuries and **5** individuals were arrested for firearm offences. The recovered firearms/ammo included 1 x .38 firearm and 24 rounds of various calibre live ammunition. The total number of persons shot since Q1 2011 is **52**, of which **16** were fatal shootings. A summary of Firearm Fatalities and Injuries as well as Homicides for the last 20 quarters can be seen Figure 9:

5. CRIMES AGAINST THE COMMUNITY (CATC)

5.1 SUMMARY


Figure 11: Crimes Against The Community (Last 5 Year Comparison 2011 - 2015)

The total for CATC in Q4 2015 was **116**, a **decrease** of **-9** offences or **-7.2%** compared to Q3 2015, as shown below in Figure 10. In comparison to Q4 2014, Q4 2015 **decreased** by **-33** offences or **-22.1%**. The total for 2015 was **586**, a year on year **increase** of **+79** offences or **+15.6%** as can be seen in Figure 11, below.

Figure 10: Crimes Against The Community (Last 5 Quarters Q4 2014 - Q4 2015)



5.2 TRENDS

Q4 2015 continues the long term downward trend with 11 of the last 12 quarters being less than 150 offences, the 1 exception being Q1 2015. A summary of CATC for the last 20 quarters can be seen in Figure 12, with Q4 figures highlighted in boxes:





6. CRIMES AGAINST PROPERTY (CAP)

6.1. SUMMARY

The total for CAP in Q4 2015 was **660**, an **increase** of **+32** offences or **+5.1%** compared to Q3 2015, as shown below in Figure 13. In comparison to Q4 2014, Q4 2015 **increased** by **+69** offences or **+11.7%**. The total for 2015 was **2,456**, a year on year **increase** of **+105** offences or **+4.5%** as shown below in Figure 14.




Figure 15: Crimes Against Property By Quarters (Q1 2011 - Q4 2015)

7. TRAFFIC COLLISIONS

7.1 SUMMARY


Figure 17: Traffic Collisions (Last 5 Year Comparison 2011 - 2015)

The total for Traffic Collisions in Q4 2015 was **327**, a **decrease** of **-77** or **-19.1%** compared to Q3 2015, as shown below in Figure 16. In comparison to Q4 2014, Q4 2015 **increased** by **+24** or **+7.9%**. The total for 2015 was **1,310**, a year on year **decrease** of **-89** or **-6.4%** as can be seen in Figure 17, below.

7.2 TRENDS

Q4 2015 continues the long term downward trend of collisions. Of note, there was a **decrease** of fatalities, from **16** in 2014 to **7** in 2015. Serious Injuries also **decreased** from **123** in 2014 to **101** in 2015. A summary of Collisions for the last 20 quarters can be seen in Figure 18, with Q4 figures highlighted in boxes:





8. DRUG ENFORCEMENT ACTIVITY (DEA)

DEA refers to arrests or drugs seized either at the border or in Bermuda.

8.1 SUMMARY


Figure 20: Drug Enforcement Activity (Last 5 Year Comparison 2011 - 2015)

The total for DEA in Q4 2015 was **92**, an **increase** of **+6** offences or **+7.0%** compared to Q3 2015, as shown below in Figure 19. In comparison to Q4 2014, Q4 2015 **decreased** by **-38** offences or **-29.2%**. The total for 2015 was **367**, a year on year **increase** of **+20** offences or **+5.8%** as shown below in Figure 20, below.

8.3 Drug Seizures Q4 2015

The Bermuda Police Service continues to work with its partners both locally and overseas to disrupt the trafficking of controlled drugs. These partners include HM Customs Bermuda, U.S. Customs and the U.S. Drug Enforcement Administration. Despite these partnerships, controlled drugs are still entering Bermuda which is evidenced in the number of 'street' level drug seizures. This can be seen in Figure 22, which shows Drug Seizures By Location:

As can be seen in Figure 22, the majority of drugs seized were at street level (**47**) while there were **21** seizures at ports (including LF Wade).

8.4 Drug Seizures Type Q4 2015

An estimated total of **17.5 kg** of controlled drugs with an estimated street value of **\$1.45 million** has been seized in Q4 2015. Cannabis was the most commonly seized drug with **14.6 kg** seized at a value of **\$948,406**. Cocaine was the next highest, with **2.8 kg** seized at an estimated street value of **\$448,372**. Heroin was the third most commonly seized drug, with **118 g** seized at an estimated street value of **\$47,554**. The type, weight and value of the drugs seized broken down by Port, Street and Overseas seizures can be seen below in Figure 23:

In comparison to Q3 2015, the value of drugs seized in Q4 2015 has **increased** by **\$593,729** with an estimated street value of **\$1.5 million** compared to **\$853,711** in Q3 2015.

² In 2015 the Department for National Drug Control figures have been used to calculate drug value with the following \$ per g value; Cocaine \$161, Crack Cocaine \$184, Heroin \$403, Cannabis \$65, Cannabis Resin \$95 and a pill of Ecstasy is \$50.

8.5 Drug Seizures Type 2015

An estimated total of **81.5 kg** of controlled drugs with an estimated street value of **\$6.7 million** was seized in 2015. This compares to **80.4 kg** of controlled drugs with an estimated street value of **\$5.1 million** was seized in 2014.

Cannabis was the most commonly drug seized in 2015 with **67.7 kg** seized at a value of **\$4.4 million.** By comparison, in 2014 **78.3kg** of Cannabis was seized with a value of **\$3.9 million**. Crack Cocaine was the second most commonly drug seized in 2015 with **6.1 kg** seized at a value of **\$1.1 million**. Cocaine was the third most commonly seized drug, with **5.4 kg** seized at an estimated street value of **\$874,180**. The type, weight and value of the drugs seized broken down by Port, Street and Overseas seizures for 2015 can be seen in Figure 24:

9.1 SUMMARY


Figure 26: Traffic Enforcement Activity (Last 5 Year Comparison 2011 - 2015)

The total for TEA in Q4 2015 was **7,325**, a **decrease** of **-493** or **-6.3%** compared to Q3 2015, as shown below in Figure 25. In comparison to Q4 2014, Q4 2015 increased by **+1,387** or **+23.4%**. The total for 2015 was **32,803**, a year on year increase of **+5,132** offences or **+18.5%** as shown below in Figure 26.

The total for CFS in Q4 2015 was **5,290**, a **decrease** of **-413** or **-7.2%** compared to Q3 2015, as shown below in Figure 28. In comparison to Q4 2014, Q4 2015 increased by **+500** or **+10.4%**. The total for 2015 was **20,538**, a year on year **decrease** of **-491** or **-2.3%**, as shown below in Figure 29.




Figure 30: Incidents By Quarters (Q1 2011 - Q4 2015)

Arrests refer to those persons arrested and brought into police custody.

11.1 SUMMARY


Figure 32: Arrests (Last 5 Year Comparison 2011 - 2015)

The total for arrests in Q4 2015 was **672**, the same as Q3 2015, as shown below in Figure 31. In comparison to Q4 2014, Q4 2015 **increased** by **+32** or **+5.0%**. The total for 2015 was **2,651**, a year on year **increase** of **+195** or **+7.9%**, as shown below in Figure 32.

12. STOP AND SEARCHES

12.1 SUMMARY


Stop and Searches are conducted in a proportionate and accountable manner and only when Police Officers have occasion to exercise lawful powers. They are carried out with courtesy, consideration and respect for the individual being stopped. While the figures are not performance indicators, they are a reflection of the frequency of engagement between proactive Police Officers and Prolific Priority Offenders. They provide an indication of police activity, particularly regarding the number of highly visible patrols in the community.

There were **158** Stop and Searches in Q4 2015, a **decrease** of **-109** or **-40.8%** compared to Q3 2015, as shown below in Figure 39. In comparison to Q4 2014, Q4 2015 has **decreased** by **-360** or **-69.5%**. A summary of Stop & Searches for the last 20 quarters can be seen in Figure 40, with Q4 figures highlighted in boxes:

13. PROCEEDS OF CRIME ACT (POCA) SEIZURES

13.1 SUMMARY

POCA seizures totalled **\$458,491** in Q4 2015, a **decrease** of **\$75,245** or **-14.1%** compared to Q3 2015, as shown below in Figure 41. The total for 2015 was **\$1,243,861**, a year on year **increase** of **+\$620,745** or **+99.6%**, as shown below in Figure 42.

Figure 41: POCA Seizures (Last 5 Quarter comparison Q3 2014 - Q3 2015)


